Points North and East For November 2016 by Jim Ogg

La Nina is settling in and the departing El Nino was a disappointment Aussie Oaks received less rain during the El Nino year than the previous hydrology year!

The Central Coast vineyards are turning and Central Coast Fall Color usually starts late in the month of October. I will be checking out Huasna, Adelaida, and the vineyards west and east of Paso Robles; western side of Salinas Valley in Monterey County, and the Edna Valley. The SMCC found some color at Pomar Junction Vineyards in late October, 2016. Yosemite Valley Black Oaks could still be promising for early November.

Many of our beaches and dunes of the Central Coast are only accessible by humans during the period from October 1st to March 1st. The best opportunity for shooting on these beaches and dunes is early in the winter season; fewer footprints, more animal tracks and some undisturbed sand ripples can still be found. The three miles of the Sand (Dunes) Spit of Montana De Oro SP is especially productive and the Pismo Dunes Preserve and Oso Flaco Dunes should be checked out.

November is the start of daytime low tide access to the local beaches. Usually low tide occurs between noon and sunset and is often very low (minus) tides. This has the benefit that the tidal pools, coves and beaches are most accessible with fewest visitors. If it is not raining the beaches have comparable temperatures to summer with more sunlight and better sun lighting angles. Some early "winter" wildflowers may start blooming in the Beach Dunes, Sea Bluffs and Coastal Scrub plant zones. Montana De Oro SP, San Simeon Point, Elfin Forest Loop Trail, East-West Ranch Bluff Trail, Estero Bluffs SB, Morro Bay SP, Pismo Dunes Preserve, Oceano Dunes and Oso Flaco

Dunes are places to look for low tide opportunities and/or "winter" coastal wildflowers.

Usually the first opportunity for the drenching rainfall Fungi seem to need is November. The Fungi then appear one-to-four weeks after. In 2005-06 we had a series of drenching rainfalls hence a great Fungi year. That year's Club trip to Cambria Cemetery succeeded in finding many Fungi including Bolettes, Fly Alaric, Chanterelles, Jack-in-the-Box, and Turkey Tail. Fungi can also be found at East-West Ranch, particularly the Southeast corner; San Simeon State Park; San Simeon Point; Stadium Park and Jim Green Trail in Atascadero; Los Osos Oaks Preserve, Eagle Rock Loop trail in El Chorro Park and Ferrini Ranch Open Space near SLO.

The Butterflies and Elephant Seals return to the Central Coast in November. The non-breeding Elephant Seals haul out at Piedras Blancas early in November. The Bull Elephant Seals start arriving mid November. Soon after their arrival they contend for control of the beaches with often bloody fights.

November is a great month to check out the opportunities of the Eastern Sierra for last fall color, first snow and the Movie sites in the Alabama Hills as shown in Sealth Image SR171, "Movie Road". The beautiful starlets of the Hollywood westerns are no longer seen near Movie Road. However the weathered, dramatic boulders of the Alabama Hills and their spectacular skyline, deserve further observation.

Bob Mihelic is taking us to the Fresno Chaffee Zoo's new African Adventure, a 13-acre expansion which features animal species in spectacular naturalistic exhibits that emulate the African plains and savannas. Proposed Amendments to the Constitution and Bylaws

To the SMCC members...

We have proposals for amendments to the Constitution and Bylaws coming up for a vote at the business part of our meeting (after the program and break) on **November 2, 2016**. The Constitution and Bylaws both require prior publication in the Galleon as notice to the members that these changes are up for a vote. We have also sent them out by Email in order to provide a little more time for the members to take a look at them.

General Admonition

Do not feel you have to proceed beyond this point if you are not particularly interested in the intricacies of the management of the club. No general member should feel obligated to do so. As I mentioned, one of our officers said when she started out at the Club she was interested in learning about photography, socializing with other photographers and not in the details of running the club. Our job at the board is to try to handle most of that. Nevertheless, we do occasionally have to bring matters to a vote by the general membership as per the Constitution and Bylaws. So that is what we are doing here.

Approval by the Board

I sent the first drafts of the three sets of proposed amendments out to our general membership about two weeks ago, more or less, and to the board before that. We have had a second draft incorporating members' suggestions (but not all of them), and a third draft incorporating changes voted in by the board at our November 26, 2016 meeting. The third draft is what is referred to here.

The proposed amendments have been approved by the board as set forth in the third draft of each. These documents are as I understand it, being made available on our Club website as they are too long to be completely published in the Galleon. There is one sentence in the set dealing with discipline that has not been reviewed or approved by the board. I added that exception as it seemed essential and would constitute a major gap if not so included. It is clearly identified in that document. So on behalf of the board, whether you read everything carefully, or wish to entrust the details to the board, please do vote to incorporate these proposed amendments into the Constitution and/or Bylaws, as appropriate, at our meeting of November 2, 2016. We will hold our business meeting after the program and break. The election of officers and at large members and this vote are both scheduled for that part of the meeting.

Details for Those Who are Interested

Anyway, I am sending these comments to accompany the (third draft) final version (we think) of the three proposed sets of amendments to the SMCC Constitution and Bylaws. These are complex documents, with strike outs for language being deleted, then bold print for new language and finally, italics and underlining and bold print all together for more recent changes to already incorporated changes. OK. Enough said. When you look at the documents, it should be pretty clear which is which. After I sent these out to Alan for the Galleon and Greg for our website, I thought of sending clean copies (just the final language) to our members, but at this late date I think that would be even more confusing — too many versions floating around.

Reasons for the Proposed Changes Regarding Notice of Proposed Amendments to the Constitution or Bylaws

For many years the only possible notice for proposed amendments has been publication in the Galleon. This has made matters somewhat difficult. In the age of Email we have proposed different forms of providing notice to take advantage of modern systems.

Reasons for the Proposed Changes to Notice of Board Meetings and General Meetings

These meetings, especially board meetings, have been difficult to schedule as once again notice is required to be published in the Galleon beforehand (for anything but regularly scheduled general membership meetings). So we have proposed modernizing the rules so that we can take advantage of notice by Email and other methods.

Reasons for the Proposed Changes to Disciplinary Action

It is no secret that the board and Club have had difficulties with a particular member this year. It is unfortunate, but I have noticed that a lot of non-profit organizations I am aware of have had problems of this nature recently. If such groups don't have standards for discipline they can be left at the mercy of a single disruptive member and find that other members no longer wish to participate in the group. Our minimal rules currently provide only for suspension. We started looking at rules for expelling a member. We used some statutory sources, such as the standards for expulsion from an unincorporated association like ours which are set forth in the California Corporations Code. When we started exploring options, other issues came up. It was suggested that we needed standards for discipline that would be less severe than suspension or expulsion. And we needed to separate temporary suspension for failure to pay dues from disciplinary suspension. Thus we have had to work out new rules providing for a broad range of disciplinary options and procedures. All include an opportunity for the disciplined person to protest decisions of the board. A decision for suspension or expulsion by the board is subject to a protest of the decision by the disciplined member to the general membership. A lot of thought has gone into the disciplinary rules, including looking at court cases testing procedures established and used by non-profit associations. Due Process and fundamental fairness in handling such matters are considerations throughout.

Please note that these amendments to the disciplinary rules ... not the suspension for failure to pay dues or basic membership rules ... will be put at the end of the bylaws and renumbered so that the bylaws aren't weighted with negativity at the outset. I didn't do renumber the drafts as I thought it would make the changes too difficult to follow.

Ouestions

If you have any questions regarding any of the proposed amendments, feel free to ask any board member at the meeting on November 2, 2016. They have carefully considered the issues.
